SCHIP Renewal- The Story Continues

For the past 10 years, SCHIP, known as FAMIS in Virginia, has provided health coverage to kids whose parents are either not offered health insurance for their family through their employer, or who cannot afford the coverage that is offered. Nationally more than 6 million children are covered by SCHIP and more than 137,000 of Virginia's children were covered at some point in 2006. This program was set to expire on September 30, but has been extended until November 16, 2007 at the current funding level.

Compromise Legislation

Leaders in both the House and Senate developed a compromise piece of legislation that would expand the program by approximately \$35 billion over five years. Estimates indicate that by 2012, a total of 3.8 million children who otherwise would be uninsured would have health care coverage under this bipartisan agreement. Both the House and Senate overwhelmingly passed this legislation. The Senate secured a veto-proof majority of 67 votes, while the House was 15 votes shy of a veto-proof margin.

On October 2, 2007, President Bush vetoed this bipartisan legislation. The President continues to advocate for his budget proposal of an additional \$5 billion for program costs over the same five year period.

The Congressional Budget Office has reported that the current funding levels,

set in 1997, are not adequate to keep up with the number of uninsured kids, so it will take at least an increase of \$14 billion in federal funding to cover children currently enrolled in these programs, with more money needed to cover additional uninsured, currently eligible children. According to these estimates, the funding proposed by President Bush's plan will not be sufficient to maintain the current eligibility levels for SCHIP.

Following President Bush's veto of the bipartisan legislation, both the House and Senate are working to obtain an override of the Presidential veto so that the SCHIP program will be adequately funded.

Normal Operation Continues

As the reauthorization process continues, Virginia's FAMIS program will continue normal operations, and will provide health care coverage to more than 83,000 children and 850 pregnant women. Without reauthorization or a continuing resolution in place, current estimates indicate that the remaining federal fiscal year 2007 allocation to Virginia will continue to sustain the FAMIS program through March 2008.

Update from DMAS

Back to School Campaign

Back to School Campaign – DMAS is currently in the midst of running their multi-faceted annual back-to-school marketing and outreach campaign. A mix of TV, radio and print ads are currently working to spread the news about child health insurance across Virginia.

As part of the annual Back-to-School campaign, FAMIS delivered materials to the Metro Richmond YMCA for the Bright Beginnings program. This is a community outreach program that provides backpacks, fall clothes and school supplies to thousands of children for the upcoming school year. Two thousand FAMIS Back-to-School flyers, FAMIS pencil cases and Smiles For Children toothbrushes were included in the backpacks which were distributed to the 15 branch locations throughout the metro Richmond and Petersburg areas.

The FAMIS program also contributed 2,000 Back-to-School English/Spanish flyers to be distributed at the CBS Channel 6 and Food Lion Annual Back-to-School school supplies giveaway event.

DMAS has also distributed more than 600,000 Back-to-School English and Spanish flyers and also 350,000 FAMIS inserts in English and Spanish for Free and Reduced School Lunch approval letters.

SCHIP Press Conference

At the request of the Robert Wood Johnson Foundation's Cover the Uninsured Initiative, the Virginia Health Care Foundation coordinated a press conference on August 21, 2007 to promote the reauthorization of the SCHIP (FAMIS) program. The event featured Secretary of Health and Human Resources Marilyn Tavenner; Tom Byrd, President of Anthem Blue Cross and Blue Shield of Virginia; Princess Moss, President of the Virginia Education Association; and two families with children covered by FAMIS. Delegate Phil Hamilton, called away at the last moment, provided remarks that were read during the event.



"Far too many kids in Virginia and across the nation are uninsured and do not receive the care they need, but things could get even worse," said Secretary Tavenner, speaking at the event. "SCHIP has been a

successful partnership between the federal government and the state, and we want it to continue and grow. SCHIP has proven to work when we give it the resources needed for success."

The press conference was attended by more than 80 supporters of the FAMIS program in Virginia, and received media attention from WTVR-TV CBS Channel 6 and the *Richmond Times-Dispatch*.

Governor's Health Reform Commission

Governor Tim Kaine created the Governor's Health Reform Commission in August 2006, and charged the Commission with making recommendations to improve the health care system in Virginia. The Commission is composed of 32 individuals representing state legislators, health care leaders, consumer and patient advocates and citizens, and was subdivided into four workgroups:

- Access to Care
- Quality, Transparency and Prevention
- Healthcare Workforce
- Long-term Care

In meetings held throughout the last year, the Commission generated more than 40 recommendations.

Access to Care Workgroup

Specifically, the Access to Care Workgroup was charged with identifying groups, regions and populations where rates of uninsured citizens are high; investigating how to improve access to health care and health insurance for these groups; and recommending Medicaid changes, funding opportunities, innovative pilots, demonstrations, or small group/individual market reforms to foster change. The Access to Care Workgroup recommended a more frequent study of Virginia's uninsured and additional funding (\$10 million) to strengthen Virginia's health safety net including community health centers and free clinics.

Recommendations

The Access to Care Workgroup recommends Virginia consider insuring additional low-income Virginians through the Medicaid and FAMIS programs. Specific recommendations include:

- Expanding Medicaid eligibility to 100% FPL for parents and caretaker adults aged 19-64;
- Including routine dental services as part of the any Medicaid eligibility expansion for parents, or include routine dental services for existing parents enrolled in the Medicaid program;
- Expanding FAMIS eligibility from 200% FPL to 300% FPL for children; and
- Increasing FAMIS Moms eligibility for pregnant women from 185% FPL to 200% FPL.

A final recommendation from this workgroup is to create a private health insurance product for uninsured Virginians with income less than 200% of FPL who have no other access to public or private health insurance.

The Story of Genia Jones

Genia Jones by day is an elementary teacher at John B. Carey Elementary School in Hampton and has a busy class of 21 students. By night she and her husband James, a student at Christopher Newport University (studying to be a music teacher), are parents to three beautiful and busy children. Genia was distributing FAMIS fliers to her students, when she took a better look and realized that she and her family might qualify. She contacted FAMIS outreach worker Julia Melendez, and the rest, as they say, is history.

Dylan, a 9-year old 3rd grade student, enjoys riding his bike and playing computer games. He is also a very good big brother. Chloe, 5, is daddy’s little girl. She loves to read and is a budding writer. Although her mom would call her a princess, liking all things pink and frilly, Chloe also loves to play with her Polly Pockets in the dirt. Evan, a smiling, cooing, 8-month old is pulling himself up and starting to crawl.

All of the children are up to date on their immunizations and have recently visited the dentist for check-ups. When asked what FAMIS had done for her family, Genia replies, “...With three children and my husband in school, we couldn’t otherwise afford the quality health care we get through FAMIS.”

Did You Know?

Managed Care in Lynchburg

Effective October 1, 2007, new managed care organizations (MCOs) will be providing health care services to FAMIS, FAMIS Plus and Medicaid managed care eligible enrollees in Amherst, Appomattox and Campbell counties and Lynchburg city.

The introduction of MCOs in the Lynchburg area means the MEDALLION program will no longer be an option for recipients in this area. After October 1, 2007, managed care eligible individuals will be enrolled in either Southern Health CareNet, Optima Family Care, or VA Premier Health Plan. Letters to recipients impacted by this expansion were mailed in late August. These letters provided recipients with a choice of the three MCOs. If the recipient did not make a choice, he/she was assigned to the MCO listed in the letter. Medicaid and FAMIS Plus recipients were instructed to call the Managed Care HelpLine [(800) 643-2273] with questions related to their MCO assignment. The Managed Care HelpLine assists enrollees in selecting a MCO, in addressing and documenting members' concerns, and in completing health status assessments that are forwarded to the assigned/chosen MCO. FAMIS enrollees were told to contact the FAMIS CPU at (866) 873-2647 for assistance with choosing their MCO.

CHIPAC Meetings Open to Public

The Children's Health Insurance Program Advisory Committee (CHIPAC) was created by the General Assembly to evaluate

Virginia's FAMIS Programs and make recommendations to the Secretary of Health and Human Resources and the DMAS Director. Meetings are open to the public, and anyone interested in children's health insurance is encouraged to attend. CHIPAC's purpose is to make policy recommendations concerning enrollment, access to and utilization of health care services by Virginia's eligible children. Upcoming meetings:

Project Connect is in its 8th year at the Virginia Health Care Foundation.
